### PRIVATE SEWER MAINTENANCE/EASEMENT AGREEMENT

The undersigned are the owners of the real property located at the following addresses located in Watsonville, California:

Due to sewer construction practices at the time these houses were built, (number of) properties have sewer laterals which join into one line which runs through the following properties before connecting to the City of Watsonville (City) sewer main. The undersigned owners desire to enter into an agreement whereby the common sewer lateral shall be jointly maintained and kept in good condition in accordance with City of Watsonville Municipal Code Section 6-3.508.

Each owner shall be individually responsible for maintaining that portion of the sewer lateral from their building foundation to the point where it joins the common lateral.

Each owner shall share equally the cost and expense of operating, inspecting, maintaining, and repairing the common joint lateral to the City sewer main. Any fines levied against the City by regulatory agencies as the result of failure of the common lateral shall be shared equally by the properties in this agreement. (if different percentages of ownership are desired, list properties and associated percentages)

This agreement will continue until mutually terminated by the owners of subject properties or at such time when one or more of the owners constructs a separate lateral connecting directly with the City sewer main. If a new agreement is not executed with the remaining owners of the common lateral, the responsibility of ownership will be divided equally among the remaining property owners listed in this agreement.

In the event that damage to the common lateral is the fault of any party of this agreement, the party causing the damage shall be solely responsible for the cost of repairs, as determined solely by the owners listed in this agreement.

This agreement is intended to run with the land of the following properties, and shall be binding on the heirs and assigns of the owners of said real property:
