The City of Watsonville hereby grants permission to Applicant to withdraw water from the hydrant specified above, subject to the conditions listed below:

1. Incurred water charges will be deducted from deposit. Remainder will be refunded.
2. Water is to be withdrawn from the hydrant(s) specified above, and from the metered outlet only.
3. **Failure to hook up to a fire hydrant without a hydrant meter attached may result in a \$371.88 unauthorized connection fee.**
4. **Operation of the hydrant valve shall be with a standard fire hydrant spanner wrench only. Pipe wrenches or the like shall not be used.**
5. Except at such times as water is being withdrawn from the hydrant, the hose or other receiving apparatus shall be disconnected from fire hydrant and the hose caps replaced on the hydrant outlets, including the metered outlet.
6. The hydrant valve shall be operated slowly and carefully, to avoid the possibility of any damage to the water mains from water hammer.
7. This permit is to be available for inspection by properly identified employees of the City of Watsonville at all times that water is being withdrawn from the hydrant. The permit is valid through expiration date shown; it may be renewed upon application
8. In addition to consumption charges, a monthly hydrant-meter availability fee of **\$321.74** will apply to hydrant meters located inside City limits, and **\$404.47** to hydrant meters located outside City limits.

### SPECIAL CONDITIONS:

9. Any violation of these conditions may result in suspension of Applicants' hydrant use privilege, and a charge will be made to Applicant for any damage to the hydrant, meter, and water system.
